SUBJECT : INTERIM GUIDELINES IN THE RENEWAL OF  
CERTIFICATES, PERMITS OR LICENSES DURING THE  
STATE OF PUBLIC HEALTH EMERGENCY

DATE : 29 JULY 2020

In the interest of public service and pursuant to subsisting laws, executive issuances and rules and regulations<sup>1</sup>, enjoining all government agencies to render full assistance and cooperation and mobilizing the necessary resources to undertake critical, urgent, and appropriate responses and measures in a timely manner to curtail and eliminate the COVID-19, the National Telecommunications Commission, by virtue of its authority vested under existing laws, hereby promulgates/issues the following interim guidelines in the renewal of certificates, permits or licenses during the period of state of public health emergency due to COVID-19 pandemic:

1. All existing certificates, permits and licenses<sup>2</sup>, to operate radio communications equipment, networks and facilities, public (telecom), broadcast, government or private, in various radio services<sup>3</sup>, expiring in the current year **shall remain valid and may be renewed on or before the last working day of December 2020 without penalties or surcharges**. Thereafter, appropriate penalties or surcharges shall be imposed.
2. Due to expediency reasons and as there are still mobility limitation issues in many regions around the country, Public
